**SENTENCE**

It is, therefore, on July 18, 2008 ORDERED and ADJUDGED that the defendant is sentenced as follows:

Count 5, 07-04-00146-I: Defendant is hereby sentenced to a 3 year term of probation. Said supervision may be transferred to the State of Pennsylvania. Defendant is ordered to serve 27 days in the Keogh-Dwyer Correctional Facility (KDCF) with credit for 27 days of jail time served. The Court imposes the following condition(s) for probation: comply with all standard conditions of probation; perform 100 hours of community service; submit to random drug monitoring; enter into and successfully complete an intensive outpatient program and follow any/all recommendations; obtain/maintain gainful employment. \$50 VCCA; \$75 SNSF; \$30 LEOTEF; \$2 per month probation supervision fee; \$2 transaction fee; \$1000 DEDR; \$50 Lab Fee. Defendant is ordered to make monthly payments of \$100. Defendant is ordered to submit a DNA sample at their own expense.

Defendant is ordered to pay restitution: \_\_\_\_\_

- Dismiss COUNTS 1, 2, 3, 4, 6, 07-04-00146-I.  Bail is exonerated.

- The defendant is hereby sentenced to community supervision for life pursuant to N.J.S.A.2C:43-6.4 with offenses occurring prior to 01/14/2004.
- The defendant is hereby sentenced to parole supervision for life pursuant to N.J.S.A.2C:43-6.4.
- The defendant is hereby ordered to serve a \_\_\_\_\_ year term of parole supervision which term shall begin as soon as defendant completes the sentence of incarceration pursuant to N.J.S.A.2C:43-7.2.
- The court finds that the defendant's conduct was characterized by a pattern of repetitive and compulsive behavior.
- The court finds that the defendant is amenable to sex offender treatment.
- The court finds that the defendant is willing to participate in sex offender treatment.
- The defendant is hereby ordered to provide a DNA sample and ordered to pay the costs for testing of the sample provided.

It is further ORDERED that the sheriff deliver the defendant to the appropriate correctional authority.

Defendant is to receive credit for time spent in custody (R. 3:27-8).
